Agreement concluded between Cross Park Montafon (hereinafter referred to as CPM) on the one hand, and the organizer below on the other hand, as follows:

Agreement

CPM, as the operator of the training center, provides the Cross Park within the designated training area for the conduct of training runs to the organizer.

CPM disclaims any liability for accidents related to training runs for athletes and third parties. The organizer declares to assume full and exclusive liability for the training track provided to him and undertakes to take the necessary safety precautions customary for training runs organized by him to ensure the physical safety of both athletes and public skiers. This includes, in particular, the proper layout of the race track, which is solely in his area of responsibility, as well as clear demarcation and securing from the general slope, proper maintenance and monitoring of the track and operation.

The organizer is aware that the conduct of training runs outside the designated training area or Cross Park is only possible in coordination with Silvretta Montafon (ski area operator), and this agreement does not apply to such cases.

The race track must be properly laid out and secured by the organizer so that runners coming off the track do not endanger or injure themselves or third parties. The rules of the IWO established by the FIS must be followed by the organizer.

The organizer must fence off the training track he operates and monitor compliance with the prohibition to ensure that unauthorized winter sports enthusiasts do not use the race track. Overall, the organizer is fully responsible for setting up all necessary safety precautions in such a way that dangers to racers and third parties are minimized to the greatest extent possible.

If, for any reason, CPM is held liable for damages by anyone because of damage related to an installation of the organizer or the operation of such installations, the organizer agrees to indemnify CPM completely from any claims or lawsuits.

After the end of each event (e.g., training period), the organizer must remove the barrier materials located at intersections (e.g., ski path) after the training period and store them at an appropriate and safe location.

Running on the ski lift facilities throughout the entire ski area is strictly prohibited for runners and coaches. ATTENTION: Ski passes are not transferable! If the cards are passed on or misused, they may be confiscated without replacement by representatives of Silvretta Montafon.

The organizer is obliged to leave the Cross Park as they found it. (e.g., trash, yellow snow)

It is expressly pointed out that any willful destruction and/or theft will be reported without exception. The on-site trainers are agents of the organizer and are personally responsible for compliance with the slope safety obligations incumbent on the organizer. Their behavior is directly attributed to the organizer, so he is also liable for their negligence, as for his own.

Agreement



Trainers and organizers are jointly and severally liable to CPM for all obligations under this agreement. As a sign of their agreement, this agreement is also co-signed by the responsible trainers.
